**Motion 1:** The Commission approves funding not to exceed \$5,800 from line item 6.02 (SSA Audit) for Eilts & Associates to perform SSA #33's 2020 Annual Audit. (21-1009)

  - a. Clean & Green

<u>Motion 1:</u> The Clean & Green Committee moves to approve funding not to exceed \$52,120 from line item 2.02 (Landscaping) for Christy Webber Landscapes' 2021 General Landscaping contract for tree pits, flower beds, and plazas, from April – November. (21-0105)

RD Motions. WJ Seconds. All in favor. Motion passes.

<u>Motion 2:</u> The Clean & Green Committee moves to approve funding not to exceed \$40,050 from line item 2.02 (Landscaping) for Christy Webber Landscape's contract for planting and maintenance of on-street planters on Milwaukee Ave. (21-0110)

Discussion – Clean & Green committee recommended the contract for Brightview Landscapes, who have performed this service the last 3 years. Multiple commissioners believe that it is time to give Christy Webber a chance to see if they provide better offerings for their higher price. DG and JH suggested dividing the street and letting two vendors service different portions so the Commissioners could judge performance. GK strongly suggested to pick one vendor or the other for the entire street. Dividing street creates extra complications and it is easier to compare year over year. Commission can always switch back if they are not satisfied in 2020. Total difference in price is approx. \$5,000.

RD motions to amend. JH Seconds. All in favor. **Motion passes.** 

<u>Motion 3:</u> The Clean & Green Committee moves to approve funding not to exceed \$70,775 from line item 2.02 (Landscaping) for Bartlett Tree Experts' 2021 Tree Care contract to maintain, prune, and update inventory for all SSA #33 trees. (21-0107)

Discussion – JW, WJ, DG bring up several questions and concerns about tree management plan, tree database, billing, and scope of work. GK recommends that if this many questions persist this motion can be tabled, brought back to Clean & Green Committee for a discussion with vendor, that voted on at Feb Commission meeting. Not urgent that this be approved this month.

RD motions to table. JH seconds. All in favor. Motion tabled.

**Motion 4:** The Marketing & Business Development Committee moves to approve Christine Pundavela as a voting member.

<u>Motion 5:</u> The Marketing and Business Development Committee moves to approve funding not to exceed \$4,046.00 from line item 1.05 (Decorative Banners) for the printing and installation of the new banner design produced by Chicago Event Graphics. (21-0102)
