  - a) Transportation

<u>Motion 1:</u> The Transportation Committee moves to approve additional funding not to exceed **\$4,000** from line item **2.05** (Streetscape Elements) to cover an increase in production and installation costs plus one additional bench from Why Not Iron. (21-0601)

RD motions. WJ seconds.

<u>Discussion:</u> GK clarifies that this is in addition to \$17,000 allocation from earlier this year for 10 benches. Additional bench would replace a damaged bench on Division Street.

All in favor. Motion passes.

<u>Motion 2:</u> The Transportation Committee moves to approve funding not to exceed \$4,900 from line item 2.05 (Streetscape Elements) for the purchase of three to six U-Line Inground Mount Picnic Tables to be installed at Metzger Court. (21-0602)

RD motions. WJ seconds. All in favor. Motion passes.

<u>Discussion</u>: WJ comments that the concerns brought from Clean & Green Committee on these tables are minimized after seeing the circular design. Commissioners would like to see some kind of branding on the tables if possible. GK would prefer to keep this pilot project simple for now and respond to branding concerns for the entire plaza at a later date. GK mentions considerable conversation will need to take place with 1<sup>st</sup> Ward and CDOT to make this project a reality, as well as other plans to activate Metzger Court.

**Motion 3:** The Transportation Committee moves to approve Erin Sian Williams as a voting member.

b) Clean & Green

<u>Motion 4:</u> The Clean & Green Committee moves to approve funding not to exceed \$2,000 from line item 2.07 (Sidewalk Litter Abatement - Supplies) for the purchase of graffiti removal equipment for the 32<sup>nd</sup> Ward Office. (21-0605)

<u>Motion 5:</u> The Clean & Green Committee moves to approve funding not to exceed **\$17,500** from line item **2.05** (Streetscape Elements) for the restoration and painting of the planter fences on Division St. to be done by Americana Ironworks & Fabrication. (21-0606)

Rd motions. JH seconds. All in favor. Motion Passes.

<u>Discussion</u>: WJ explained to the Commission that this work will be more in depth and comes with a 1-year warranty. GK explained that we have the budget to spend on the larger bid this year.
