<u>Motion 3:</u> The Committee recommends the Commission move to approve funding not to exceed **\$1,500** from line item 2.06 (**Public Art**) for the Samuel Schwindt "A Quivering Life" installation for the Wicker Park Fest Arts Area. (22-0503)

4. Neighborhood Guide + Annual Report Art Cover
