- AH updated the committee on discretionary Safety Rebates spend of \$1000.00 to Schooner Learning Academy (1667 N Western Ave) for glass replacement and antigraffiti film and \$820.00 to Liquor Park (1937 W North Ave) for anti-graffiti film.
- Committee recommended that additional Holiday tree options be researched and brought to Commission, as they were dissatisfied with both the artificial and real tree prices proposed by Illuminight and Christy Webber, respectively.
- AH updated the committee on the PR RFP and its focus on additional content creation and more media opportunities.
- AH updated the committee on Illuminight's installation of lights in Metzger Court in anticipation of the Tuesday Night Farmers Market starting on 7/9, along with a ribbon cutting ceremony for Jyl Bonaguro's new sculpture in Metzger Court, as soon as it has been repaired.
- PM mentioned efforts to implement Placer.ai in future WPBCC and SSA #33 marketing strategies, and intends to invite SSA committee members to an informational presentation from Placer.ai to see if the SSA and WPBCC could split the expense in 2024-2025.
