# 14. Vote "One Big Thing"

submissions, 5 were out of the state. Judges were Anna Cerniglia, Richard Rezak and Sam Marts. We lost 2 judges at the last minute, Sam was able to step in. We also solicited public comments. DG presents top 3 in order.

BN- would like to point out the Commission respects the committee's decisions usually Mr. Ticus asks, did the committee share their decision? DG- yes, there was a lot of discussion.

DG explains the decision to open the RFP nationally and internationally instead of keeping it local.

Mr. Lofton asks- who is the review board at the City? It seems like there is no clear set of guidelines.

Mr. Varndell- would like to go on record to state the process was flawed, the SSA should have cast a wider net, he was able to show how easy it is to add another proposal and gain the interest of another artist. It pains him to see the lines of WP / B further blurred BN- would like to see the buck on the 606.

JH- is there a vote to spend any money? Thanks to the committee for all their hard work Mr. Ticus- Vice President of WPC, thanks to Pamela for coming out to WPC, it doesn't seem like many residents, businesses knew about this project

<u>Motion:</u> on behalf of the Arts Committee, to accept Lynn Basa's proposal, Workers Cottage Parklet, for the public art installation at the corner of Milwaukee and Wood.
