Discussion- Mr. Varndell states, my understanding is that the purpose of these grants is to give a little bit of seed money to help get programs off the ground. BN- yes, that's one philosophy. RD-part of the reason we choose to support this event is because we want representation at Do Division, this event also provides an excellent opportunity for local businesses to participate in the fashion show. Mr. Rivera-I used to own a store on Milwaukee Ave and this type of activity is something you see in NY, this is an art, it is needed here, no amount of compensation would be enough for what Ms. Gomez does.

DG- this is the first year that the Chamber is a full partner, the Chamber exists to support businesses, supporting the bike stage is another part of our mission for sustainability. JH-there is an education component to this as well. Mr. Hutton- if you are going to be a green fest, why not bring in the "sunflower" or a tesla battery, something more unique than the bike stage.

Discussion- Mr. Varndell- for years we were told that the donations at the gate were going to the school, I was under the impression that the \$5,000 was coming from the promoter to the school.

DG- we have struggled with this for years. The City now includes a budget line for festivals, they recognize them as a neighborhood benefit. Mr. Hutton asks why isn't Pritzker the beneficiary? Answer- Pritzker is not in the SSA.

<u>Motion 4:</u> to approve the funding of a private security rebate program in an amount not to exceed \$25,000 to provide rebates of up to \$2,500 per business or residence from line item 5.05 (General Safety and Security Programs).

Discussion-Mr. Hutton- what is the general safety / security programs? BN- the programs include safety enhancement rebates, it's a co-pay, we were brainstorming at a committee level, we found this to be the best way to maximize the money and allow people to use it where they feel they need it most. Mr. Hutton- so you ignore what the people and the aldermen want? Mr. Varndell- this is a lot more equitable, this is a decent compromise. Mr. Rivera- to clarify, the hiring of private security would use off-duty cops and sheriffs, this program is used in 9 out of 50 SSAs, both aldermen expressed a desire that \$50,000 be used for private security, to use half of that is not going to work. There was conversation with Nike about possibly contributing some money to a program. I would ask that you go back and rethink the idea, expand the program. DG- Jose, you have said this has been successful in other SSAs but there are NO metrics. Mr. Rivera- I can pull the figures for you from Comstat. Ms. Coorens- you are comparing this to Wrigleyville and it is not the same. BN- we have not heard from a single taxpayer who wants this. Mr. Rivera- we are 72% worse this year than last year in strong-armed robberies and carjackings. We will help you gauge the desires of the PIN holders, we will pay for mailers, host meetings. You have a good suggestion on the table, expand the amount of money, \$40,000 would be fine. BN- we don't want to put all of our eggs in one basket, that's why we have a whole host of programs. Mr. Rivera- I want to see you use the money in the right way, educational programming is not going to help. RD- are you suggesting we table it or expand the amount of money now? BN- of we make the motion today, we can start this program this month. JH- with all due respect, the SSA is place-based and this program is place-base, it allows the PIN holder to decide. Mr. Rivera will help write a new program
