a. Executive, delivered by BN

<u>Motion 1:</u> on behalf of the Clean, Green and Safe Committee, to fund sidewalk snow removal in an amount not to exceed \$82,366 from Line Item 2.12 (sidewalk snowplowing), starting November 15, 2017 and ending April 15, 2018. This will be performed by Christy Webber Landscapes on North, Damen, Division, Ashland and Western and Cleanslate on Milwaukee.

Discussion? This is the exact same cost as last year. If we don't get a letter of support, we shouldn't sign the contracts. JH- is there a contingency plan? We are hoping it doesn't come to that.
